## 4) FIRST AID MEASURES

### 5.2. Special hazards arising from the substance or mixture

#### HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

Do not breathe combustion products. ## 6) ACCIDENTAL RELEASE MEASURES
